HAWAII LEGISLATIVE REPORT

2015 Legislative Report - Brief Recap

Prompt payment by general contractors to subcontractors is a continual issue. Retainage issues and quicker job close outs are often the subject of legislation in other states. Other state legislation is monitored because if another state comes up with a solution, Hawaii can copy and modify it for Hawaii subcontractors.

Changes to the contractors licensing law have helped to curtail the rampant unlicensed contractor situation including advertising restrictions and forfeiture of tools and equipment. More consumer education is key to inform the buyer of potential downfalls.

Additional resources are needed for RICO, the agency which chases the unlicensed men. There have been improvements legislatively with retainage equality (between generals and subs) and prompt payment but they have not solved the problem and need major improvement.

Biggest challenge is defending the subcontractors from hostile legislation proposed by general contractors. Most of the time is spent on defense instead of a positive, collective, beneficial offense. Please go to www.tilehawaii.com under Updates for the full

CONSTRUCTION REPORT

Construction industry in the state is predicted to be significantly promising. Challenges are subcontractor and labor availability and material and equipment costs are escalating.

In 2014, increase in housing prices and shortage of inventory. A single-family home was \$670,000.00 (up 4.5%). Condominiums at \$350,000.00. Out-of-state investments in real estate, primarily from Korea and China is affecting the shortage. Statewide shortage is 12,000 units. City is encouraging contractors to provide 4,000 affordable housing units over five years.

Commercial projects are taking the lead in the issuance of building permits. But private construction permits increased 15.9% in 2014. Total of 23,000 building permits issued in 2014 but 32% less than 2013.

Modernization projects at the Honolulu International Airport is budgeted at \$750 million.

Kapolei- numerous residential projects, widening of Kalaeloa Boulevard, industrial business park, shopping and theater complex, elementary school.

Rail – Kiewit has completed the first three miles of the 20 mile, \$5.8 billion system that will include 21 stations but expected completion date of 2018 is doubtful.

Need to watch what will arise from Transit-Oriented Development (TOD). Programs to develop neighborhoods for 15 of the 21 rail station areas.

Building Permits – City moving towards streamlining building permit processing (Honolulu Land Information System (HOLIS-HONline) and electronic Plan Review (ePlans).

Tourism and Federal Dollars – Tourism experiencing lower than expected
