SIGNATORY MEMBERS

A person, firm or corporation who is signatory to the Mason Union, Local 1 and duly licensed by the State of Hawaii Contractors License Board in any of the following classifications as they now exist or as they may be amended in the future and who is principally and actively engaged as a specialty contractor of subcontractor in such line(s) of endeavor:

- C-51 Tile Contractor
- C-51a Cultured Marble Contractor
- Solid Surface
- C-51b Terrazzo Contractor

Each company is entitled to one vote in all matters that are brought for a vote before the Association. Proxy vote shall not under any circumstance be allowed.

Each Signatory Member will be entitled to name a representative to attend Association meetings, may hold office, may serve on Association committees, or otherwise participate in the affairs and activities of the

Association and have signatory representation. The representatives, as named by the Signatory Member, shall be officers or bonafide supervisory or management employees of the Signatory Member's company. Signatory membership dues, per year are \$150.00, which is subject to change.

ASSOCIATE/SUPPLIER MEMBERS

Any person, firm or corporation who is engaged in the sale or manufacturing of supplies, materials and/or equipment used by Signatory Members and is not a signatory contractor to the union. Bonding and insurance firms, financial institutions, professional engineers architects and estimating services and similar persons, firms or corporations who provide services to Signatory Members and whose membership as an Associate/Supplier Member is approved as such by the Board of Directors.

Associate/Supplier membership shall be on a company basis with each Associate/Supplier Member being entitled to name one representative to participate in the affairs and activities of the Association. Representatives of the Associate/Supplier Members may attend any meetings of the Association and have the privilege of the floor, may be appointed as members of any standing committee, but shall not vote. Associate/Supplier membership dues, per year are \$250.00, which is subject to change. year are \$150.00, which is subject to change.
